However, the said orders have since been stayed by the Hon'ble Securities Appellate Tribunal (SAT), on the respective appeals made by the said parties. The next date of hearing in the matter is on June 16, 2022. The interim stay continues.  Further, apart from proceedings under section 11 and 11B of SEBI Act, adjudication proceedings under Section 15 of SEBI Act had also been initiated in the year 2012 and after having various hearings and written representations on multiple occasions during these years, the said proceedings are now concluded by adjudicating officer vide its order no. Order/VV/AA/2021-22/12063-12069 and Order No. Order/VV/AA/2021-

	22/12070-12078 dated May 31, 2021.
	However, an appeal against the said order(s) passed by the adjudicating officer of "SEBI" has been filed before the Hon'ble Securities Appellate Tribunal "SAT".
